Update on Share Repurchase Program 2018

In the framework of the Share Repurchase Program 2018, as announced on February 13, 2018, the Company reports today that during the period from April 30 until May 4, 2018, the following transactions took place through the central order book of the regulated market of Euronext Brussels:
